Business To Be Transacted

1. To request for nominations and select a chairman for the Parish Land Committee
2. To request for nominations and select a vice chairman for the Parish Land Committee
3. **Disclosure of Interests**
Interests in accordance with the Localism Act 2011 and the Parish Council code of conduct.
To receive councillors' declarations of interest regarding matters on the agenda and consider any written requests or dispensation as a result. Any changes to register of interests should be notified to the clerk.
4. To receive apologies and reasons for absence in accordance with the Local Government Act 1972 S85 (3)
5. **Minutes of the Previous Meetings to be agreed and signed as a true record.**
To approve and sign the minutes of the Parish Land Committee meeting held on 22nd March 2023 as a true record.
6. **To exclude the public for agenda items 7, 8 and 9 the following resolution must be passed.**
Under the public Bodies (Admission to Meetings) Act 1960, the public and representatives of the press and broadcast media be excluded from the meeting during the consideration of **agenda item 7,8 and 9** whereby individual land contractual arrangements are to be discussed, as the business and publicity would be prejudicial to the public interest because of the confidential nature of the business to be transacted.

Matters For Consideration and Resolution

8. To receive an update on the contractual arrangements for Parish Farm and agree any actions required.
9. To receive an update on the parish land contractual arrangements and agree any actions required.
